Einhell focuses on digitalization and sustainability using the osapiens HUB

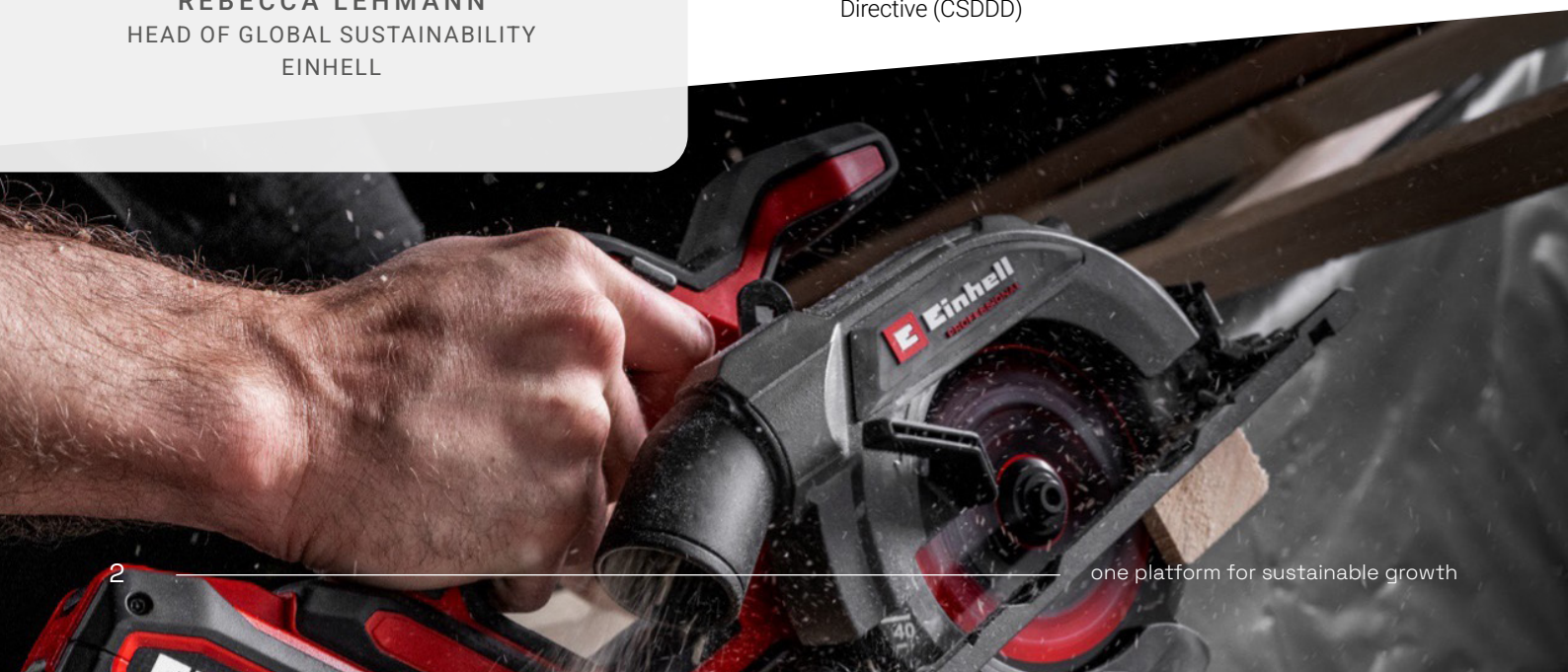
